Both legal regulations establish the exemption of the temporary visa requirement for tourist and business visas to enter Peru, for nationals of the People's Republic of China and the Republic of India, holders of valid and current ordinary passports, provided that they prove at least one of the following conditions:

a) Be holders of visas with a minimum validity of six (6) months for the United States of America, Canada, the United Kingdom, Australia or for a State belonging to the Schengen Area.

b) Have permanent residence in the United States of America, Canada, the United Kingdom, Australia or in a State belonging to the Schengen Area.

(*) Reciprocal suspension of the Visa Exemption Agreement entered into force by exchange of notes between the Republic of Peru and the Republic of Korea in the year 1982.
