ALL visas have to be applied for in person. Appointments have to be required at consulperu-londres@rree.gob.pe. After the appointment, they are approved by the Consul General and it takes a minimum of 5 working days to issue them.

Tourism Visas

British and Irish nationals do not require a Tourist Visa when traveling as tourists to Peru. Neither do nationals from the following countries:

South America	Argentina, Bolivia, Brazil, Colombia, Chile, Ecuador, Guyana, Paraguay, Suriname, Uruguay & Venezuela.
North America	Canada, USA and Mexico.
Central America and Caribbean	Antigua & Barbuda, Bahamas, Barbados, Belize, Costa Rica, Dominica, Granada, Jamaica, Panama, Saint Christopher and Nevis, Saint Lucia, Saint Vincent and The Grenadines, Trinidad and Tobago.
Europe	Andorra, Austria, Belgium, Belarus, Bulgaria, Cyprus, Croatia, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Holy See, Hungary, Iceland, Italy, Latvia, Liechtenstein, Lithuania, Luxemburg, Macedonia, Malt, Moldova, Monaco, Netherlands, Norway, Poland, Portugal, Russian Federation, Rumania, San Marino, Serbia and Montenegro, Slovenia, Slovak Republic, Spain, Sweden, Switzerland, Turkey, Ukraine.
Asia	Brunei Darussalam, Philippines, Hong Kong, Indonesia, Israel, Japan, Malaysia, Republic of Korea, Singapore, Thailand & Taiwan.
	Chinese nationals may enter Peru without a visa if they are UK or US residents for a minimum of 6 months at the moment of entry to Peru
Oceania	Australia, Fiji, Cook Islands, Marshall Islands, Solomon Islands, Kiribati, Micronesia, Nauru, Niue, New Zealand, Palau, Papua New Guinea, Samoa, Tonga, Tuvalu & Vanuatu.
Africa	Republic of South Africa

Applicants must bring:

- Valid passport (machine readable / with barcode)
- 1 [Visa Application](#) form fully filled in and signed
- 1 colour photograph (passport size, white background)
- Return ticket or reservation stating dates of arrival and departure to and from Peru
- Hotel reservation and/or tourism package confirmation in Peru.
- Proof of solvency (the 3 latests month statements showing a minimum of £1,000 plus a mini-statement from a cash machine on the day that the visa is requested).

- If you are a student, please provide a letter from your school confirming your studies. If you are working, please provide a letter from your employer confirming your employment status. Please make sure that the letter includes your full name and passport number.
- *Please be advised that a police record (**Police National Computer Form - Form 3019B**) and/or a personal interview with a consular officer may be required.*

- © Tourists are allowed to stay in Peru for up to 183 days.
- © Nationals of countries not mentioned above require a Tourist Visa and must book an appointment for a personal application at mcastro@conperlondres.com
- © Nationals from countries that need a Tourist Visa and **who are not residents in the United Kingdom** are subjected to a special authorization from the Immigration Office in Lima in order to obtain a visa. This application could take several days to be processed.

Business Visas

Nationals from the following countries do not need a Business visa to travel to Peru:

South America

 Bulgaria, Croatia, Cyprus, Iceland, Liechtenstein, Norway, Romania and Switzerland

Nationals of countries not mentioned above require a Business Visa and must book an appointment for a personal application at mcastro@conperlondres.com.

Applicants must bring:

- Valid passport (machine readable / with barcode)
- [Visa Application](#) form fully filled in and signed
- 1 colour photograph (passport size, white background)
- Return ticket or reservation stating dates of arrival and departure to and from Peru.
- [Fee](#)
- A letter from your employer confirming your employment status and the nature of your activities in Peru. Please make sure that the letter includes your passport number and it mentions that all expenses are covered by your employer
- Proof of solvency of your company.
- In case your trip is related to a Peruvian counterpart, letter from such Peruvian company signed by the company's representative, and his/her peruvianID number, or passport number and / or Foreigner's Identity Card number (Carnet de Extranjería, for foreigners)
- *Please be advised that a police record (**Police National Computer Form - Form 3019B**) and/or a personal interview with a consular officer may be required.*

- © Business people are allowed to stay in Peru for up to 90 days.

Journalist Visas

Nationals from the following countries do not need a Journalist visa to travel to Peru:

Europe

Schengen Area (Austria, Belgium, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Italy, Latvia, Lithuania, Luxemburg, Malt, Netherlands, Poland, Portugal, Slovenia, Slovak Republic, Spain, Sweden)

Bulgaria, Croatia, Cyprus, Iceland, Liechtenstein, Norway, Romania and Switzerland

Nevertheless, Journalists will still need authorization for bringing equipment into Peru. For more information please write to mcastro@conperlondres.com.

Nationals of countries not mentioned above require a Journalist Visa and must book an appointment for a personal application at mcastro@conperlondres.com.

Applicants must bring:

- Valid passport (machine readable / with barcode)
 - [Visa Application](#) form fully filled in and signed
 - 1 colour photograph (passport size, white background)
 - Letter from the production company explaining the purpose of the trip
 - Letter from the Peruvian Institution confirming the approval of your filming there (if this is the case)
 - Flight itinerary
 - If you are bringing equipments to Peru, bring the [Kit List form](#) fully filled and signed
 - Drones: Tell your Peruvian Fixer because there is a special permit for that and needs to be requested in Peru
 - The visa is issued free of charge.
 - [Letter of compromise](#), fully filled and signed
- © They are allowed to stay in Peru for up to 90 days.
- © Once the filming is completed in Peru, a copy of the finished work produced with material gathered during the trip to Peru will be sent to the Peruvian consulate, visa section, in DVD format.

Religious Visas

Religious Visas have to be requested in Peru. In order to apply for this type of visa you need to contact:

consulate you would be able to claim your visa, so they can send the authorization to the Peruvian Consulate in that country.

Applicants must bring:

- Valid passport (machine readable / with barcode)
- [Visa Application](#) form fully filled in and signed
- 1 colour photograph (passport size, white background)
- Flight ticket or reservation, stating dates of arrival to Peru.
- The visa is issued free of charge.

Resident Working Visas

Resident Working Visas have to be requested in Peru. In order to apply for this type of visa you need to contact:

Once the visa has been authorized by the Peruvian immigration authorities, the Resident Working Visa can be issued by any of our consulates abroad. You need to inform the immigration authorities in which consulate you would be able to claim your visa, so they can send the authorization to the Peruvian Consulate in that country.

If you have chosen to claim your visa at the Peruvian Consulate in London, please ask for an appointment at mcastro@conperlondres.com.

Applicants must bring:

- Valid passport (machine readable / with barcode)
- [Visa Application](#) form fully filled in and signed
- 1 colour photograph (passport size, white background)
- Flight ticket or reservation, stating dates of arrival to Peru.
- A letter from your employer confirming your employment status and the nature of your activities in Peru and the a letter of the Peruvian counterpart company signed by the company's representative, including Peruvian ID number (DNI, in case of Peruvian nationals) or passport number and / or Foreigner's Identity Card number (Carnet de Extranjería, for foreigners)

A person who is already in Peru could request the change of his or her immigration status to the DIGEMIN, without having to leave the country.

Student Visas

Nationals from the following countries do not need a Student visa to travel to Peru:

Europe

Schengen Area (Austria, Belgium, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Italy, Latvia, Lithuania, Luxemburg, Malt, Netherlands, Poland, Portugal, Slovenia, Slovak Republic, Spain, Sweden)

Bulgaria, Croatia, Cyprus, Iceland, Liechtenstein, Norway, Romania and Switzerland

- ☉ If you are going to Peru for an internship, please apply for Student Visas as stated below.
- ☉ If you are going to study in Peru, please ask the institution in which you will study to coordinate with DIGEMIN your permanence in Peru.
- ☉ Applicants for Student Visas shall coordinate the issuing of their visas with the institution where they will study and/or carry out their internship. This institution will have to carry out the visa application process in Peru before:
